My calendar for the First Quarter 2004 was filled with meetings and hobby related politics, the "ugh" part of all my jobs. It included a Division Board Team meeting on January 17, attendance at the NMRA Board of Trustees (BOT) meeting in February and the PSR Board Meeting in March. Scattered in between these dates were many more little meetings with various members of our Division Board Team concerning membership, incorporation, the convention, and events. It's a great relief that that part is behind me now and I can look forward to getting back to having fun and seeing you at our events. Events begin with the one being held on April 3rd in Las Vegas and then April 17th in California. Flyers are in this Order Board. As a reminder, please do check the Events section on our Private website: www.cajondiv.org.

NATIONAL NEWS

Yes, and as many of you have written me asking what I think concerning the Long Range Plan (LRP), one of the key topics at the BOT meeting was the LRP. My advice is to read the LPR that is in your Scale Rails magazine and VOTE. Don't listen to all the gossip that is swirling around. If it isn't written in the new regulations it hasn't been determined. Gossip is gossip, most are half-truths or false. What is true is that a committee of Trustees has been formed to decide the issues "after" the results of the LRP vote are known.

What is also true is that a Trustee has a fiduciary responsibility to make decisions in the best interest of the NMRA and is not solely there as a representative of his Region. So if you have questions, he is the best person to address your concerns.

I honestly never realized the power of the seventeen-member BOT. The power of the NMRA President pales compared to BOT power. Every budget item, every policy item must be approved by "them." Ah-h, the revelation of "who" the real "they" and "them" are that I hear many of you say "don't know nothing." But YOU hold the absolute power by your vote. So I urge you to read and VOTE!

PSR Trustee, Bob Sherlock, will reiterate the many decisions from the BOT meeting in his next Dispatch column but since that won't be out again for another couple of months, I take time here to highlight just a few. The NMRA address labels should be mailed out this month and yes, you can reorder them. The 2005 NMRA calendar preparation is in full swing. If you have a photo that you would like to submit for consideration, contact and send to Brent Lambert, Kalmbach Memorial Librarian. His address is on the inside cover or your Scale Rails.

The BOT also voted to have a new membership classification called RAIL PASS. The Rail Pass membership classification provides the opportunity for non-members to gain the NMRA experience of being a member. A non-member can become a member for six months for a single payment of \$9.95. Rail Pass membership includes receiving the Scale Rails magazine and all membership rights except voting. This class of membership is only available to new or lapsed members, once in a lifetime. While this membership is not renewable it can be converted into any other membership class.

REGIONAL NEWS

The PSR Board met on March 6th in Glendale, CA, site of the 2004 LA Division sponsored PSR convention. It was a long drive, and a super long meeting that equaled an exceedingly long day. Except for three, the entire PSR Board

was in attendance. I guess I shouldn't complain about "long" as four of the Board members came in from Arizona.

Accompanying me were Cajon Board Team members Carl Heimberger, Dave Villeneuve, and Bill Jacobs. Carl, Convention Co-Chair, was there to assist presenting our '05 Convention plans. Dave, as new Superintendent, was invited to meet the PSR Board and see first hand the inner workings of the PSR. Bill attended as a prelude to being on the PSR Board with his candidacy for PSR Trustee.

As a result of the PSR membership survey concerning the issue of non-members attending PSR Conventions, the Board voted that non-members could attend PSR Conventions but would pay a \$10-20 surcharge. The exact surcharge to be determined by the host convention group.

Bill Mergard stepped forward to fill the vacancy of PSR Historian. Only one vacant position now remains and that is Region Education Chair. If you know of someone that might be interested, please let me know. This position isn't overly time-consuming, It involves writing a column in the Dispatch to disseminate National Education news to Region members, doing a couple of reports a year, and being a contact person. A position overview is available.

After much ado and lengthy discussion, the PSR Board was able to vote unanimously to grant the Cajon Division permission to conduct the 2005 Convention. The long discussions held were not directly related to granting approval to host the convention but rather how much of the net convention pie (\$\$) the PSR should receive from each convention and when it would be effective. Discussions offline from the meeting are still continuing as well as evaluations, philosophies and reasons why we have conventions.

Progress report on the 2004 PSR Convention in LA indicates that they are moving right along and lining up some really fun activities for attendees. It includes a couple of great prototype tours, a full line of clinics, Live Auction MWTM sessions and a big Train and Trade show held within walking distance of the convention hotel, not to mention great hobby shopping. More details will be in the Dispatch. The Glendale Hilton is nice and very reasonable at \$89 a night, especially for the Los Angeles area. The room rates for the convention are really \$99, but as part of their 50th Anniversary celebration, the LA Division is subsidizing \$10 per room night to make it as affordable as possible for you to attend.

Note to all Cajon members: If you are planning to attend the LA Convention, do let me know (or maybe you won't want to tell me..haha). I'm helping to chair the Live Auction and I'll make you feel right at home helping me. It'll be fun, I promise.

CAJON NEWS

Bob Chaparro transported and gave to me the Historian files from Bob Faley, our Division Historian who had to resign due to health reasons. I cannot begin to tell you what an asset Bob has been to this Division. The word "great" does not begin to measure his achievements in just two short years. Literature Review

A Very, Very Occasional Column by Bill Jacobs

Many of my colleagues at work and socially know I'm one of those "train nuts," so I'm the recipient of quite a few pictures, articles, and other railroad connected trivia. Probably you are, too. Ordinarily, I smile politely, take the gift, and discreetly stow it away. This one, however is just too good to pass up-and it came from my boss.

In the May 2004 issue of *British Heritage* magazine, there is a feature story about Isambard Kingdom Brunel, and his "Atmospheric Railway." Now Brunel was called a great Victorian engineering genius-this was in 1844-having designed the Great Western Railway, a noted suspension bridge, and more than one trans-Atlantic paddle wheel steamship. Two other engineers, Samuel Clegg and Jacob Samuda had just demonstrated a novel railroad propulsion system in Ireland. This design had a piston enclosed in an airtight pipe secured between the rails. Steam engine powered pumping stations located beside the tracks

every so often drew a vacuum in front of the piston and it was propelled forward. The piston was attached to the lead train car by a flat plate that was attached to the piston and extended through a slot that was cut the entire length of the pipe!

Now, I initially thought-Ireland-St. Patrick's Day, leprechauns-this has to be a joke. But there are pictures of a section of this pipe at the Teignmouth and Shaldon Museum in Devon.

It was actually built, but it was a maintenance bonanza. Train speed hit 28 miles per hour-for awhile. Since the pipe had to be sealed to draw the vacuum, and rubber seals weren't around yet, the slot was sealed with leather treated with tallow. Sure enough the leather hardened up pretty fast and rodents loved the tallow. And I can't imagine how turnouts would work-the pipe appears to be at least 12 inches inside diameter. Within a year the line was converted to regular steam engines and lived happily ever after.
